ITEM 4

This contract may be extended per special provision 004-004.

ITEM 8

Material requests shall be issued by work order. Each work order shall specify items and quantity to be delivered. The contractor will have 3 weeks (21 calendar days) from the date of the work order to deliver the materials specified on the work order.

Contract time charges shall begin upon issuance of “Authorization to Begin Work” letter. One hundred and twenty (120) working days have been designated for this contract. Working days shall be computed and charged in accordance with Article 8.3.1.5 “Calendar Day.”

Individual work order charge days shall run concurrently with contract time charges.

In accordance with Article 8.6 “Failure to Complete Work on Time,” liquidated damages shall be charged for failure to complete each work order in the specified number of days. The amount assessed per day for liquidated damages shall be as specified in accordance with special provision 000-658.

ITEM 9

Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in the plans will be requested for delivery.

ITEM 8003

Traffic paint shall be delivered in 250 gallon totes. Unit of measurement “Each” is defined as one (1) tote.

Glass beads shall be delivered in 2000 pound palletized boxes. Unit of measurement “Each” is defined as one (1) box.
