By signing this proposal, a bidder acknowledges that he/she has a copy of the "Standard Specifications for Construction of Highways, Streets and Bridges", adopted by the Texas Department of Transportation, November 1, 2014. This specification book may be purchased from the Department.

ITEM 3 – AWARD AND EXECUTION OF CONTRACT

Each contract awarded by the Department is independent and separate from other contracts held by the Contractor. If the Contractor is awarded multiple contracts, they must be equipped, possess or acquire the necessary materials and be sufficiently staffed to fulfill all contracts at the same time.

Material requests shall be issued by Work Order. Each Work Order shall specify items and quantities to be delivered as well as days to complete the Work Order.

Prior to beginning operations, the Department will arrange a preconstruction conference between representatives of the Department and the Contractor to discuss execution of the Contract.

Work orders will be scheduled and directed by the assigned TxDOT representative.

Work orders will be written for a minimum of 250 TONS delivered for any single unique bid item in the Contract.

ITEM 4 – SCOPE OF WORK

This contract allows for one (1) extension allowed by Special Provision 004-004 provided both the Contractor and TxDOT agree.

ITEM 6 – CONTROL OF MATERIALS

ITEM 8 – PROSECUTION AND PROGRESS

Contract time charges shall begin upon issuance of "Authorization to Begin Work" letter. One hundred and twenty (120) Working Days have been designated for this contract. Working Days shall be computed and charged in accordance with Article 8.3.1.5 "Calendar Day."

Individual Work Order charge days shall run concurrently with Contract time charges.

The Contractor's driver shall report to the State's representative at the time of arrival at the final delivery location and obtain a signature documenting the date and time on the haul ticket which will include the Work Order number.

Notify the Maintenance Supervisor when encountering any unforeseen delays.


In accordance with Article 8.6 "Failure to Complete Work on Time," liquidated damages shall be charged for failure to complete each Work Order in 21 calendar days.


