ITEM 8010 - CUT-BACK ASPHALT:

Minimum delivery quantities will be 5,000 gallons.

Transport truck will be equipped with transfer pump and required hoses to transfer material from the transport to TxDOT storage tanks or distributors. Hoses will be compatible with 3 in. cam lock type connections.

Failure to provide required pump and hoses may result in rejection of the transported load.

Document wait time, in excess of 2 hr., when required to remain at a TxDOT designated location until unloaded. Demerge charges will be invoiced in 15 minute increments.

Make all deliveries between the hours of 7 A.M. and 3:30 P.M. CST unless prior arrangements have been made with the Maintenance Supervisor.
