



Contract Prosecution: Each contract awarded by the Department stands on its own and has such, is separate from other contracts. A Contractor awarded multiple contracts must be capable and sufficiently staffed to concurrently processes and/or execute all contracts at the same time.

**Project Description -** This project shall consist of the purchase and delivery of Brine solution, (Material Only), to TxDOT maintenance yards or specified locations within the Laredo District. Request for material will be made through independent work orders. See estimate and quantity sheet for type and quantity materials.

### **ITEM 2: INSTRUCTION TO BIDDERS**

By signing this proposal, a bidder acknowledges that she/she has a copy of the "Standards Specifications for Construction of Highways, Street and Bridges", adopted by the Texas Department of Transportation, November 1, 2014 2014. This specification book may be purchased from the Department.

### **ITEM 3: AWARD AND EXECUTION OF CONTRACT**

Materials requests shall be issued by Work Order to the Contractor a minimum of 24 hours in advance. Each Work Order shall specify quantities to be delivered, location of delivery, and days to complete Work Order. A minimum of 500 gallons per work order will be called out on each Work Order per site.


## **ITEM 4: SCOPE OF WORK**

### **ITEM 6: CONTROLS OF MATERIALS**

Use materials from pre-qualified producers. A list of materials producers pre-qualified by the Construction Division (CST) of the Texas Department of Transportation (TxDOT) can be found at the following website.

### **ITEM 8: PROSECUTION AND PROGRESS**

Material requests shall be issued by work order. Each work order shall specify items, quantity, and location for material to be delivered.

Contract time charges shall begin upon issuance of "Authorization to Begin Work" letter.

One hundred and twenty (120) working days have been designated for this contract. Working days shall be computed and charged in accordance with Article 8.3.1.5 "Calendar Day."

Individual work order charge days shall run concurrently with contract time charges.

In accordance with Article 8.6 "Failure to Complete Work on Time," liquidated damages shall be charged each day for failure to deliver the material within the specified timeframe. For this contract, the vendor will have a maximum of 21 calendar days for non-emergency requests from the date of the work order to delivery the material. For emergency requests, the vendor shall have 10 hours to deliver the material.

The amount assessed per day for liquidated damages shall be as specified in accordance with Special Provision 000-658.

Various bid items and their associated quantities have been provided within this Contract to establish bid prices for the proposed work. Actual work performed as directed will be paid utilizing these prices with no further compensation made regardless of the final quantities.

### **ITEM 9: MEASUREMENT AND PAYMENT**

In accordance with the Article 9.2 "Plans Quantity Measurement" plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery. Maintenance sections may request quantities varying from those shown in the plans to meet their needs.

### ITEM 8032: WINTER WEATHER MATERIAL (MATERIALS ONLY)

This a contract for supplying brine solution material on an as need callout-basis.

All loads will be inspected by TxDOT personnel. Any indication of petroleum products will not be accepted and will result in load being rejected at the vendor's expense. If petroleum is found in brine solution, vendor shall be responsible for cleaning TxDOT brine tanks at the vendor's expense.

Transport truck will be equipped with transfer pump and required hoses to transfer material from transport to TxDOT storage tanks. Details on the size of pumps and hoses needed will be specified on the work order. Failure to provide required pump and hoses may result in rejection of the transported load.  $\Box$ 

For Emergency Operations (pick up, ITEM 8032-6005), TXDOT will contact the vendor who shall make arrangements to receive TXDOT personnel and equipment to pick up requested materials within 10 hours. For Emergency Operations (delivery, ITEM 8032-6064), the vendor shall deliver the material within 10 hours of the request.

A 24-hour notice is required prior to delivery of the material.

A 1 hour notice is required prior to delivery of material for emergency requests.

The maintenance supervisor will make the arrangement for the materials to be delivered. An email will be sent by the TxDOT Maintenance office to the vendor's point of contact to verify the date and time of the order.

The contractor is responsible for furnishing and delivering the to the County Maintenance yard or locations indicated in the Work Order. The delivery hours will be Monday through Friday for 7:00AM to 5:00PM.






