

#### **ITEM 4: SCOPE OF WORK**

The contract may be extended twice if in the judgment of the Engineer, the contractor has satisfactorily fulfilled the terms and conditions of the contract. The extension must be agreed upon in writing by both parties to the contract and may be extended for an additional period of time not to exceed the original contract time period. The extended contract may be for additional quantities up to the original bid quantities plus any quantities added by an approved change order. A transport truck shall be equipped with a transfer pump and required hoses to transfer material from the transport to the TxDOT storage tanks. Hose shall be compatible with a 3-inch cam lock type connection.

Failure to provide the required pump and hoses may result in rejection of the transported load.

This contract is for small quantities only. A work order will be issued to the contractor with a minimum of 24 hours' notice. The contractor shall be able to provide agreed upon amounts as needed.
