Contract time charges shall begin upon issuance of “Authorization to Begin Work” letter. One hundred and twenty (120) working days have been designated for this contract. Working days shall be computed and charged in accordance with Article 8.3.1.5 “Calendar Day.”

Individual work order charge days shall run concurrently with contract time charges.

In accordance with Article 8.6 “Failure to Complete Work on Time,” liquidated damages shall be charged each day for failure to deliver the material within the specified timeframe. For this contract, the vendor will have a maximum of 2 weeks (14 calendar days) from the date of the work order to deliver the material. The amount assessed per day for liquidated damages shall be 5% of the estimated cost of the Work Order, not to be less than \$250 per day and not to exceed \$1000 per day.

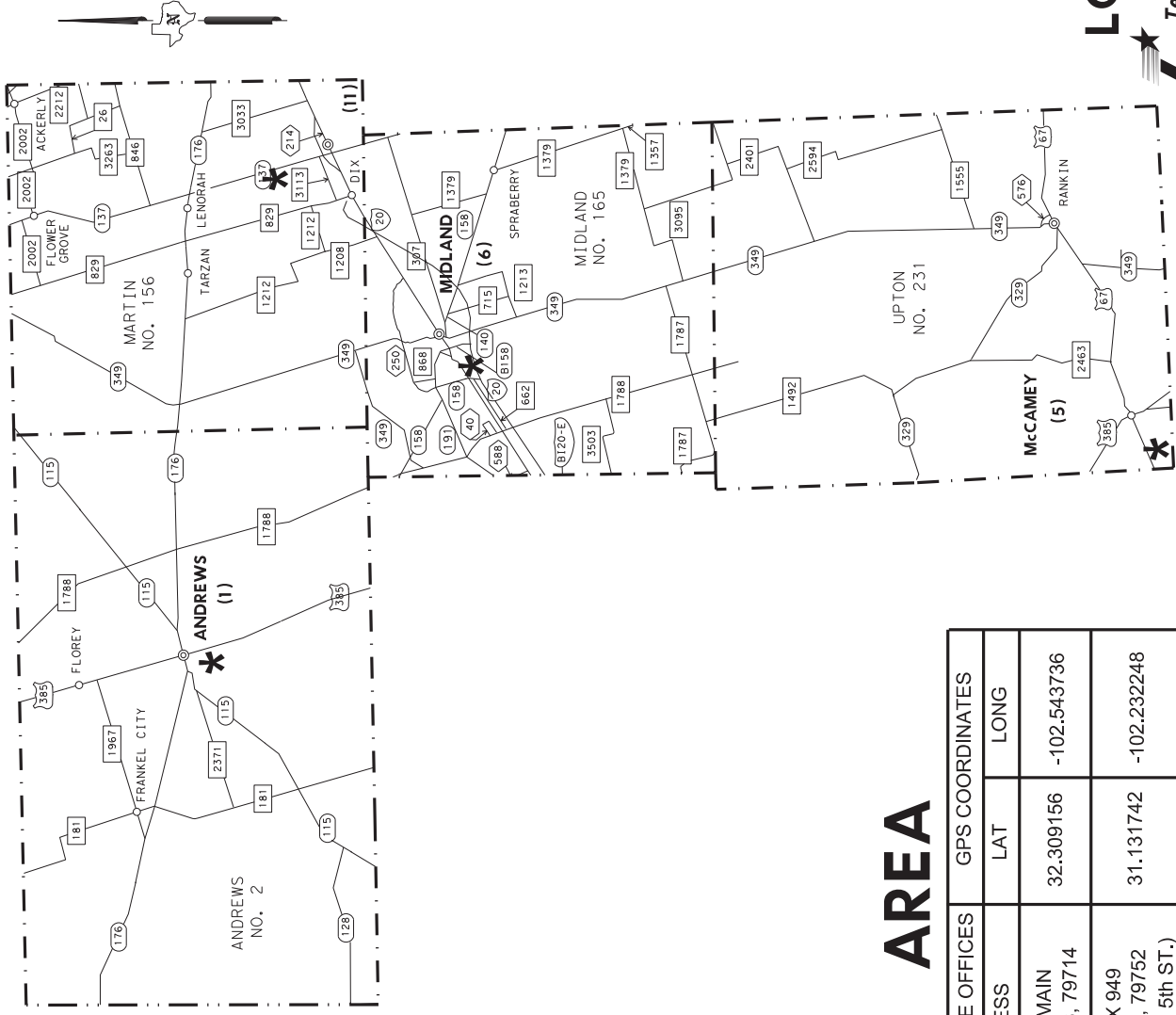
### **ITEM 9 Measurement and Payment**
