

By signing this proposal, a bidder acknowledges that he/she has a copy of the “Standard Specifications for Construction of Highways, Streets and Bridges”, adopted by the Texas Department of Transportation, November 2014. This specification book may be purchased from the Department.

Section 10.4 – Scope of Work

Prior to beginning operations, the Department will arrange a coordination call between representatives of the Department and the Contractor. In this meeting, the representatives from all parties will discuss the Contract, proposed procedures, and plans for performing the work while providing safe passage for traffic at all times. Specifications, unusual conditions, and other pertinent items regarding the work will also be discussed. Limit the use of the roadway for the hauling of material to legal loads. Keep the traveled surfaces used in hauling operations free of dirt or other materials.

In accordance with Article 10.4.3.1, this contract may be extended twice not to exceed 548 calendar days for the entire contract term if mutually agreed.

Section 10.8 - Prosecution and Progress:

There are 183 calendar days on this contract. Calendar days will be charged in accordance with Article 10.8.2., "Contract Term".

Types of accepted haul vehicles include end dumps and belly dumps. Some narrow ROW locations require end dumps due to limited space.

Each work order will specify a delivery site by the bid item in the contract and quantity to be supplied. The minimum amount of material to be ordered on an individual work order is 100 tons. There are 30 working days allowed to complete each work order.

Invoices are not required and will not be used for payment. Payment quantities shall be reconciled with the District Contract Specialist each month.

Item 8016 – Aggregate for Surface Treatments (Materials Only)

No pre-coating of aggregate will be required.

Volcanic stone with a maximum dry loose unit weight of 60 lbs./cu.ft. will be used for the Ty E uncoated aggregate.

Meet SAC B or better.

Aggregate may be redirected by the maintenance supervisor for delivery to a road instead of the maintenance yard. Redirected loads will remain within the county that ordered them, and price adjustments for such deliveries will be considered.

For mileage/freight costs used in bidding, deliveries to the maintenance yards should be used.

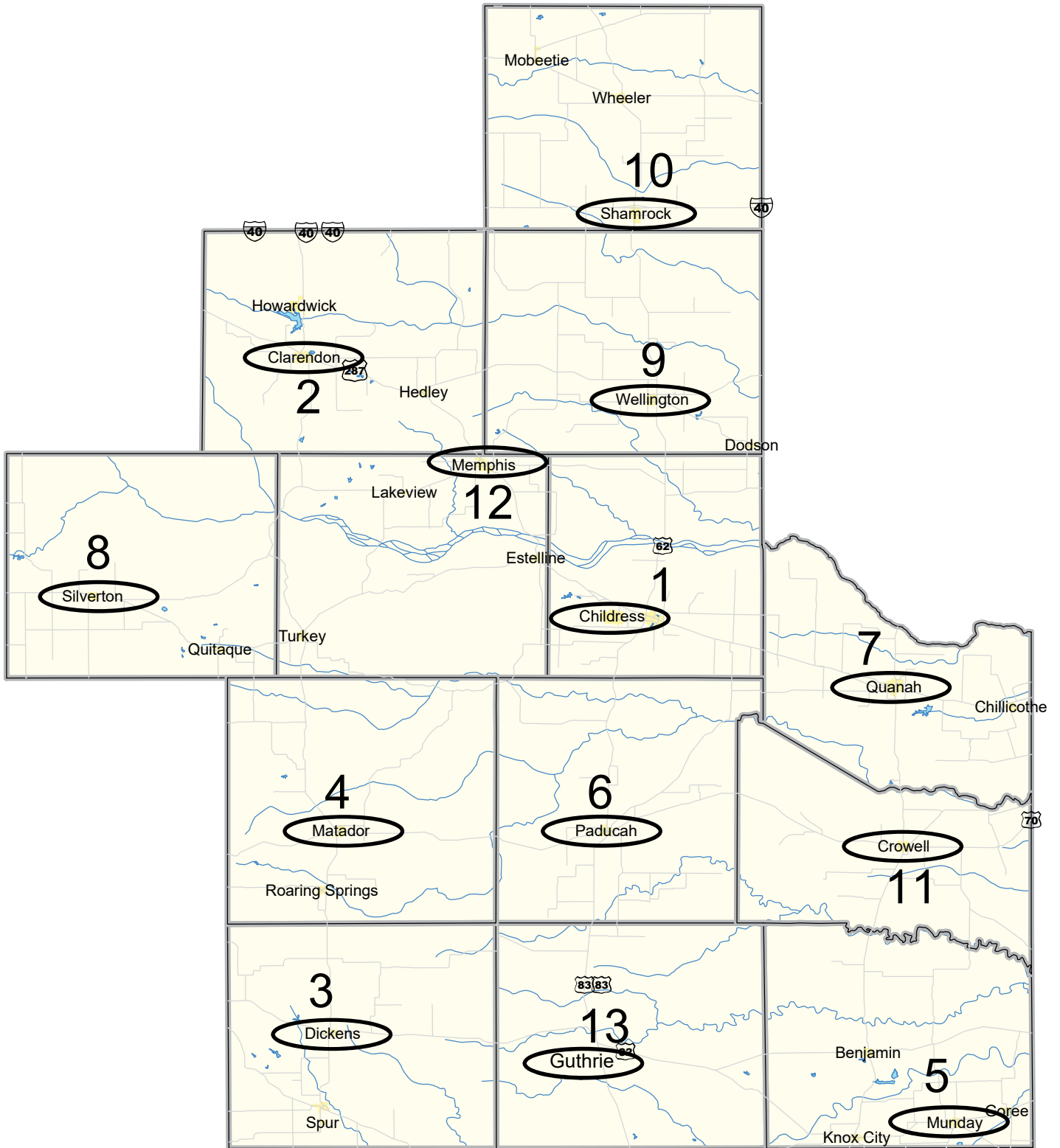
