#### **SECTION 10.4 - SCOPE OF WORK**

This Contract requires the Contractor to provide Materials in accordance with ITEM 8010 ASPHALTS, OILS, AND EMULSIONS (MATERIALS ONLY) by the following method(s):

1. Delivered by the Contractor to a designated location as defined in each WORK ORDER issued by TxDOT or the assigned representative.

In accordance with Article 10.4.3.1, this Contract may be extended twice not to exceed 540 Calendar Days for the entire contract term if mutually agreed.

#### **SECTION 10.8 - PROSECUTION AND PROGRESS**

Section 10.8.2, Contract Term will be 6 months (180 Calendar Days). Calendar Days will be charged in accordance with Article 10.8.2., "Contract Term".

Section 10.8.3., Work Orders issued will specify the following:

- 1. The type and quantity of material to be delivered and/or picked-up each day,
- 2. The Contractor's delivery location(s),
- 3. The number of WORKING DAYS to complete the WORK ORDER,
- 4. The type of haul vehicle the Contractor shall use in the delivery.

Contractor deliveries and TxDOT pickups will typically occur between the hours of 7:00AM and 4:00 PM CST. Prior arrangements will be made with the Engineer if deliveries or pickups are outside these hours.

Contractor's driver shall report to the Engineer or representative at the time of arrival at the delivery location and obtain a signature documenting the date and time on the material ticket which shall include the **WORK ORDER** number.

#### ITEM 8010 ASPHALTS, OILS, AND EMULSIONS (MATERIALS ONLY)

Delivery costs incurred by the Contractor are subsidiary to this Item.

Minimum delivery quantity for Emulsion (CSS-1H) (GAL) will be a transport load.

Minimum delivery quantity for Emulsion (CRS-2) (GAL) will be a transport load.

Transport trucks shall be equipped with transfer pump and required hoses to transfer material from the transport to TxDOT storage tanks or distributors. Hoses shall be compatible with 3 inch cam lock type connections.

Failure to provide required pump and hoses may result in rejection of the transported load.

All transports must have a seal attached to the draining device and other openings.

Monitor the temperature of the material in the truck before shipping to ensure that it does not exceed 140°F and is not lower than 120°F at delivery. The Department will not accept or pay for delivery of any mixture produced above 140°F.

The Plant is the designated sampling location unless otherwise approved by the Engineer.




