ITEM 10.3 Award and Execution of Contract

Material requests shall be issued by work order. Each work order shall specify items, quantity, and location for material to be delivered.

ITEM 10.6 Control of Materials

ITEM 10.8 Prosecution and Progress

Material requests shall be issued by work order. Each work order shall specify items, quantity, and location for material to be delivered.

Contract time charges shall begin upon issuance of “Authorization to Begin Work” letter. One hundred and twenty (120) working days have been designated for this contract. Working days shall be computed and charged in accordance with Article 8.3.1.5 “Calendar Day.”

Individual work order charge days shall run concurrently with contract time charges.

In accordance with Article 8.6 “Late Delivery Damages,” actual damages shall be charged each day for failure to deliver the material within the specified timeframe. For this contract, the vendor will have a maximum of 2 weeks (14 calendar days) from the date of the work order to deliver the material. The amount assessed per day for actual damages shall be 5% of the estimated cost of the Work Order, not to be less than \$250 per day and not to exceed \$1000 per day.

ITEM 10.9 Measurement and Payment

In accordance with Article 9.2 “Plans Quantity Measurement,” plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery. Maintenance Sections may request quantities varying from those shown in the plans to meet their needs.

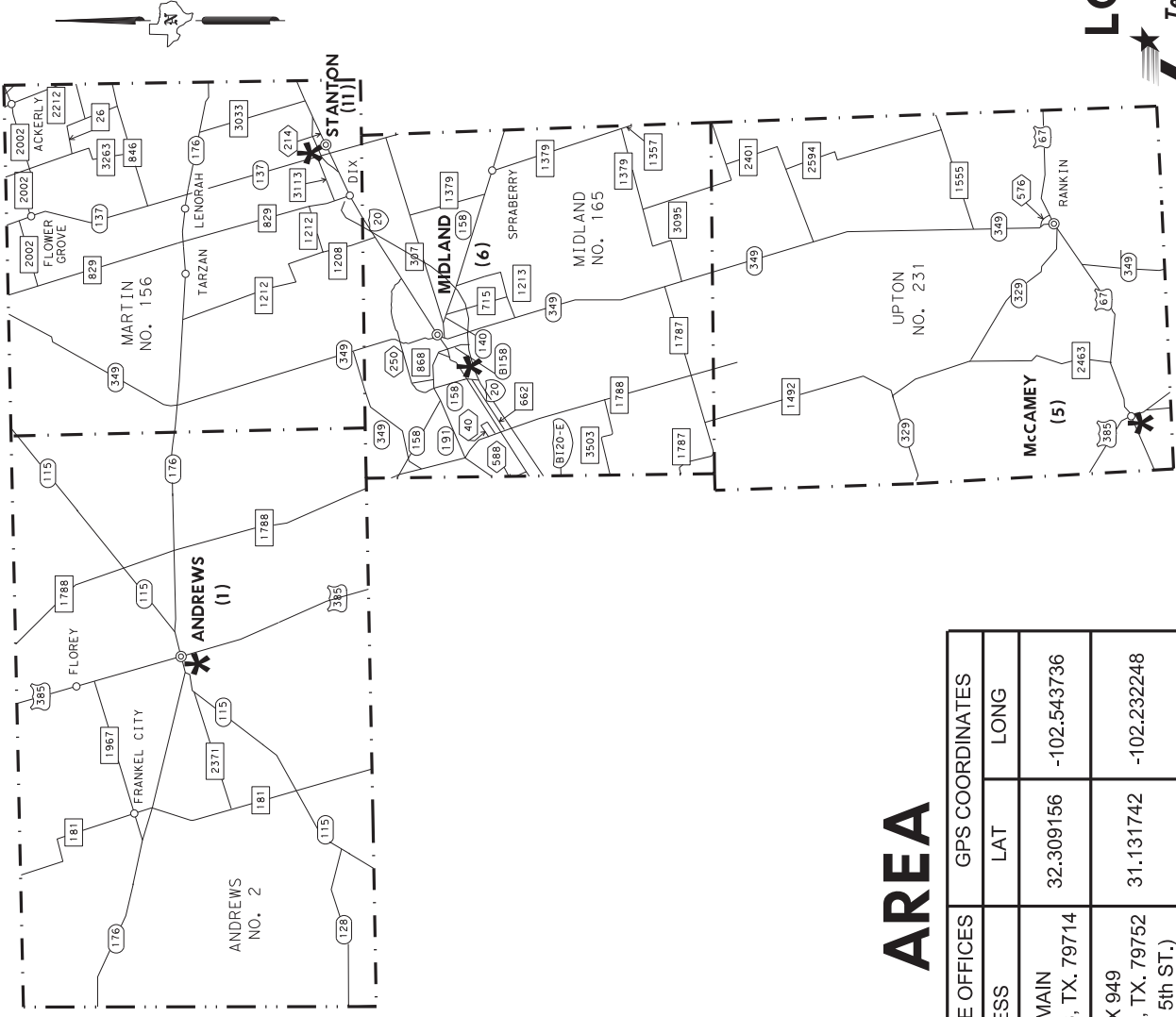
