

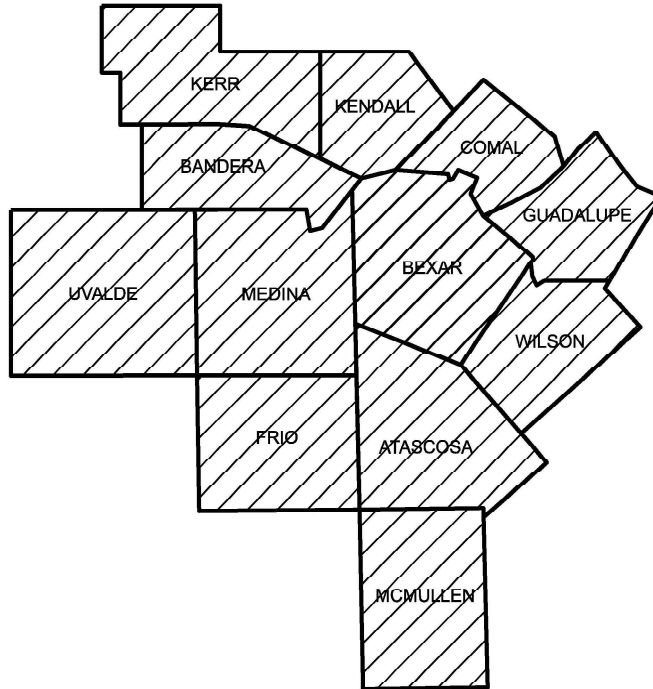

Section 10.2 - Instructions to Bidders

Section 10.4 – Scope of Work

Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in the plans will be requested for delivery.

Limit the use of the roadway for the hauling of material to legal loads. Keep the traveled surfaces used in hauling operations free of dirt or other materials.

In accordance with Article 10.4.3.1, this contract may be extended once not to exceed 730 calendar days for the entire contract term if mutually agreed.

Section 10.8 - Prosecution and Progress

There are 365 calendar days on this contract. Calendar days will be charged in accordance with Article 10.8.2., "Contract Term".

All work on this contract will be issued by individual work order via email. Provide and maintain a dedicated email address for receipt of work orders and correspondence throughout the term of this contract.

Each work order will specify a delivery site by the bid item in the contract and quantity to be supplied. The minimum amount of material to be ordered on an individual work order is 100 TONS.

There are seven (7) calendar days allowed to complete each work order, and work orders for this material type will be sent with no later than a ten (10) business day lead time.

Section 10.9 – Measurement and Payment

Furnish the tare and gross weight of all vehicles used to deliver materials for the contract.

Item 8020 – RipRap (Materials Only)

The delivery of the material on this Contract will be non-site specific. Work orders may request delivery of materials to any state-maintained highway within the limits of the maintenance section(s) identified in the plans.

All deliveries / transports shall be made with end dump trucks.

Contact the receiving Maintenance Section Supervisor at least 24 hours prior to delivery.

Deliver material during TxDOT maintenance section business hours only. Deliveries outside of these times will not be allowed, unless approved in advance by the Maintenance Section Supervisor.

In addition to the complete destination address, each delivery ticket must be clearly marked with the work order number, NIGP Code shown on work order, and a unit of measure conversion factor if required.

The Contractor's driver shall report to the Maintenance Section Supervisor, or his representative, at the time of arrival at the final delivery location and obtain a signature documenting the date and time of delivery.
