#### SECTION 10.4 – SCOPE OF WORK

This Contract requires the Contractor to provide Materials in accordance with ITEM 8040 LIMESTONE ROCK ASPHALT (MATERIALS ONLY) by the following method:

1. Delivered by the Contractor to a designated location as defined in each WORK ORDER issued by TxDOT or the assigned representative.

In accordance with Article 10.4.3.1, this contract may be extended twice not to exceed 540 Calendar Days for the entire contract term if mutually agreed.

#### **SECTION 10.8 – PROSECUTION AND PROGRESS**

Section 10.8.2, Contract Term will be 6 months (180 Calendar Days). Calendar Days will be charged in accordance with Article 10.8.2.. "Contract Term".

Section 10.8.3., Work Orders issued will specify the following:

- 1. The type and quantity of material to be delivered,
- 2. The Contractor's delivery location(s),
- 3. The number of WORKING DAYS to complete the WORK ORDER,
- 4. The type of haul vehicle the Contractor shall use in the delivery.

## The Contractor shall have the capability to deliver material using belly dumps, super dumps/end dumps, or flow boys/live bottoms, as haul vehicles.

Contractor deliveries will typically occur between the hours of 7:00AM and 3:30 PM CST. Prior arrangements shall be made with the Engineer if deliveries or pickups are outside these hours.

Contractor's driver shall report to the Engineer or representative at the time of arrival at the final delivery location and obtain a signature documenting the date and time on the haul ticket, which will include the **WORK ORDER** number.

#### ITEM 8040 – LIMESTONE ROCK ASPHALT (MATERIALS ONLY)

#### A minimum delivery will be 4 truckloads.

Transport truck will deliver material with an end dump trailer at locations specified in each **WORK ORDER**.

Delivery of material Monday through Friday during business hours only. Deliveries outside of
