ITEM 4: SCOPE OF WORK

This contract will be a 180-day, (6 month), contract and may be extended per Special Provision 010-001, section 10.4.3.1, Contract Extensions.

ITEM 8: PROSECUTION AND PROGRESS

Materials requested shall be issued by work order. Each work order shall specify items, quantity, and location for materials to be delivered. A Pre-Work meeting will be scheduled by the District Maintenance office prior to any material being delivered. Brine Salt shall be delivered in Super Sacks, approximately 2000 lbs. each.

Minimum order will be one truck load.

Contract time charges shall begin on the date specified for delivery in each individual Work Order letter.

Once an order for material has been placed, the contractor will have ten (10), calendar days, from the delivery date specified, to provide the material.

Various bid items and their associated quantities have been provided within this Contract to establish bid prices for the proposed work. Actual work performed as directed will be paid utilizing these prices with no further compensation made regardless of the final quantities.
