

**Item 7037-6001**, Janitorial Services (Daily, Weekly, and Monthly), will be paid by the month. These services will be performed between the hours of 5:30 p.m. and 6:00 a.m. on Monday, Wednesday and Friday, excluding holidays observed by TxDOT.

For any day when janitorial services required for that day (daily, weekly or monthly) are not satisfactorily completed, one day's pay will be deducted from the Contractor's monthly payment. One day's pay will be determined by dividing the monthly bid price by 13 (working days per month).
