**General Requirements and Covenants**

**Project Description** – This project shall consist of the purchase and delivery of materials only, Type I Road Salt for the Lubbock District. Materials shall be delivered to TxDOT offices listed in plans. **Note: Delivery shall be in end dump type truck.**

Each contract awarded by the Department stands on its own and as such, is separate from other contracts. A contractor awarded multiple contracts, must be capable and sufficiently staffed to concurrently process any or all contracts at the same time.

**Section 10.4 – Scope of Work:**

Prior to beginning operations, the Department will arrange a coordination call between representatives of the Department and the Contractor. In this meeting, the representatives from all parties will discuss the Contract, proposed procedures, and plans for performing the work while providing safe passage for traffic at all times. Specifications, unusual conditions, and other pertinent items regarding the work will also be discussed. Limit the use of the roadway for the

hauling of material to legal loads. Keep the traveled surfaces used in hauling operations free of dirt or other materials.

In accordance with Article 10.4.3.1, this contract may be extended once not to exceed 360 calendar days for the entire contract term if mutually agreed.

**Section 10.8 - Prosecution and Progress:**

There are 180 calendar days on this contract. Calendar days will be charged in accordance with Article 10.8.2., "Contract Term".

Each work order will specify a delivery site by the bid item in the contract and quantity to be supplied. There are 7 working days allowed to complete each work order. Additional days for work order completion may be granted by the receiving office if agreed to and documented in the work order at time work order request.
