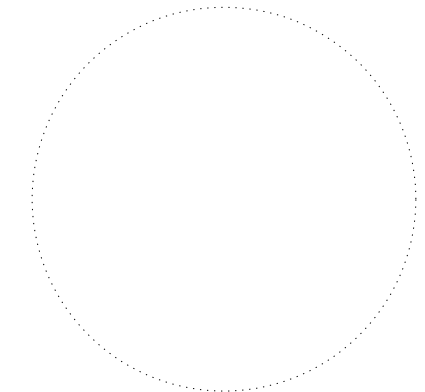



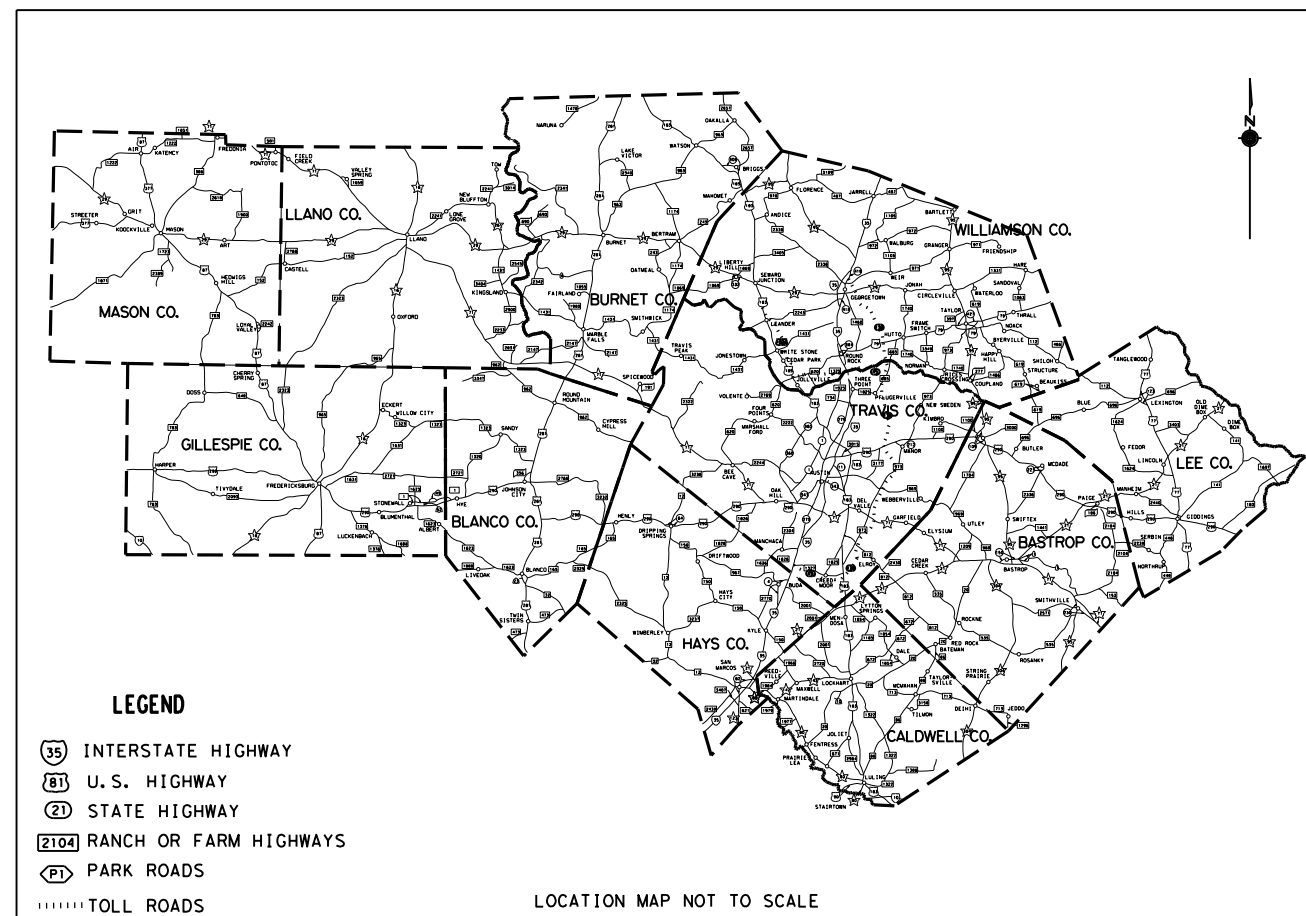

All questions submitted that generate a response will be posted through this site. The site is organized by District, Project Type (Construction or Maintenance), Letting Date, CCSJ/Project Name.

Written notice will be given to begin work on this project.

Work must begin within seven (7) calendar days after such notification. Time charges will begin when work begins regardless if it falls within seven (7) calendar days of the notification to begin work.

The contractor will have **“one hundred twenty” (120)** calendar days to complete all work under this contract.

Work under this contract shall consist of **“Flex Base”** at various locations in **“Bastrop, Blanco, Burnet, Caldwell, Gillespie, Hays, Lee, Llano, Mason, Travis, and Williamson Counties”**.

References to manufacturer's trade name or catalog numbers are for the purpose of identification only. Similar materials from other manufacturers are permitted if they are of equal quality, comply with the specifications for this project, and are approved.

If work is performed at Contractor's option, when inclement weather is impending, and the work is damaged by subsequent precipitation, the Contractor is responsible for all costs associated with replacing the work, if required.

The roadbed will be free of organic material prior to placing any section of the pavement structure.

Equip all construction equipment used in roadway work with highly visible omnidirectional flashing warning lights.

Each contract is considered separate and individual from others. Requirements to complete work on any or all contracts may occur at the same time. If requests are issued at the same time, it is expected that the work will be completed in the time frame allowed.

ITEM 2 – INSTRUCTIONS TO BIDDERS

A work order will be issued to the contractor for specific items and quantities to be delivered as well as days to complete the work order.

This Contract includes non-site specific work. Multiple work orders will be used to procure work of the type identified in the Contract at locations that have not yet been determined.

ITEM 6 - CONTROL OF MATERIALS

The Contractor is responsible for furnishing all materials included in this contract. Materials provided by Contractor will be new unless otherwise shown on the plans or approved. The Contractor must receive approval from the Engineer prior to ordering materials for this contract.

The Contractor is required to have sufficient supply of material to complete repair work within the allotted time.

Give a minimum of 1 business day notice for materials, which require inspection at the Plant.

ITEM 7 – LEGAL RELATIONS AND RESPONSIBILITIES

No significant traffic generator events identified.

ITEM 8 – PROSECUTION AND PROGRESS

In accordance with Article 8.6 "Failure to Complete Work on Time," liquidated damages shall be charged each day for failure to meet each work order. This will include:

1. Failure to deliver at the starting date or continually progress on the work order.
2. Failure to deliver the required materials per day.
3. Failure to complete work order within 3 weeks (21 calendar days) from the issue date on work order.

Contractor is responsible for obtaining annual overweight tolerance permit if hauling material which exceeds the legal road weight.

ITEM 8007 – FLEXIBLE BASE (MATERIALS ONLY)

Work order will direct delivery method and truck capabilities, (end dump or belly dump).
