



All questions submitted that generate a response will be posted through this site. The site is organized by District, Project Type (Construction or Maintenance), Letting Date, CCSJ/Project Name.

Written notice will be given to begin work on this project.

Work must begin within seven (7) calendar days after such notification. Time charges will begin when work begins regardless if it falls within seven (7) calendar days of the notification to begin work.

The contractor will have "One hundred twenty" (120) calendar days to complete all work under this contract.

Work under this contract consists of "Seal Coat Aggregate Material Delivery" at various locations in "Bastrop, Blanco, Burnet, Caldwell, Gillespie, Hays, Lee, Llano, Mason, Travis, and Williamson Counties".

Prior to beginning operations, the Department will arrange a preconstruction conference between representatives of the Department and the Contractor. In this meeting, the representatives from all parties will discuss the contract, proposed procedures and the plans for performing the work while providing for safe passage of traffic at all times. Specifications, unusual conditions, and other pertinent items regarding the work will also be discussed. Limit the use of the roadway for the hauling of material to legal loads. Keep the traveled surfaces used in hauling operations free of dirt or other materials.

Each contract is considered separate and individual from others. Requirements to complete work on any or all contracts may occur at the same time. If requests are issued at the same time, it is expected that the work will be completed in the time frame allowed.

ITEM 3 – AWARD AND EXECUTION OF CONTRACT

A work order will be issued to the contractor for specific items and quantities to be delivered as well as days to complete the work order and expected delivery date.

This Contract includes non-site-specific work. Multiple work orders will be used to procure work of the type identified in the Contract at locations that have not yet been determined.

ITEM 6 - CONTROL OF MATERIALS

Use materials from pre-qualified producers. A list of material producers pre-qualified by the Construction Division (CST) of the Texas Department of Transportation (TxDOT) can be found at the following website: https://www.txdot.gov/business/resources/producer-list.html

The Contractor is responsible for furnishing all materials included in this contract. Materials provided by Contractor will be new unless otherwise shown on the plans or approved. The Contractor must receive approval from the Engineer prior to ordering materials for this contract.

The Contractor is required to have sufficient supply of material to deliver within the allotted time.

Give a minimum of 1 business day notice for materials, which require inspection at the Plant.

Furnish uncontaminated materials of uniform quality that meet the requirements of the plans and specifications. Materials may be rejected if evidence of contamination is present. Additional sampling for acceptance may be required.

Delivery of material will not be accepted without scale certifications and tested/approved material received 48 hours prior to scheduled delivery.

ITEM 8 – PROSECUTION AND PROGRESS

Time charges will be in accordance with Article 8.3.1.5 "Calendar Day".

In accordance with Article 8.6 "Failure to Complete Work on Time," liquidated damages shall be charged each day for failure to meet each work order. This will include:

1. Failure to deliver at the starting date or continually progress on the work order.

2. Failure to deliver the required materials per day.

3. Failure to complete work order within 3 weeks (21 calendar days) from the issue date on work order.

The amount assessed per day for liquidated damages shall be 1 % of the estimated cost of the work order, not to be less than \$200 per day and not to exceed \$500 per day.

ITEM 9 – MEASUREMENT AND PAYMENT

In accordance with Article 9.1," Measurement of Quantities," furnish the tare and maximum gross weights as well as the volume capacity of all vehicles, trucks, truck-tractors, trailers, semitrailers, or combination of such vehicles used to deliver materials for the contract. Also, furnish calculations supporting these weights and capacities. Provide all measurements required for pay a minimum of 2 days before the equipment is used.

In accordance with Article 9.2 "Plans Quantity Measurement," plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery.

Contractor is responsible for obtaining annual overweight tolerance permit if hauling material which exceeds the legal road weight.

SS 8039 – AGGREGATES FOR SURFACE TREATMENTS (MATERIALS ONLY)

Previously tested aggregates delivered to the locations, which are found to contain excessive quantities of dust (more than 0.5 percent passing the no. 40 sieve) during pre-coating, stockpiling or hauling operations, will be rejected. Use test method Tex-200-F, Part II, for testing.

Report to the State's representative at the time of arrival at the locations and obtain a signature documenting the date and time.

Table 3 Los Angeles Abrasion, % Max, is lowered from 35 to 30 and is applicable to all aggregates.

Table 3 Magnesium Sulfate Soundness, % Max, is lowered from 25 to 20 and is applicable to all aggregates.

All aggregate will be SAC B or better.
