**General Requirements and Covenants - Items 1 thru 9**

**Project Description** – This project shall consist of the purchase and delivery of materials only, Superpave Mixtures, Type SPD PG 70-22, SPD PG 76-22, and SPB PG 64-22 for the Callahan, Shackelford, and Haskell County Maintenance Sections. **This contract is non-site specific. Material should be bid assuming delivery to any point in the county specified. "Pickup" line item should be bid assuming no freight cost as TxDOT vehicles will be retrieving material when this item is selected.** Materials shall be delivered to the locations specified in Work Orders. Estimated quantities are specified in the plans.

Location 1: Callahan County Maintenance Section  
Location 2: Shackelford County Maintenance Section  
Location 3: Haskell County Maintenance Section

Each contract awarded by the Department stands on its own and as such, is separate from other contracts. A contractor awarded multiple contracts, must be capable and sufficiently staffed to concurrently process any or all contracts at the same time.

**Item 3 – Award and Execution of Contract**

Material requests shall be issued by Work Order. Each Work Order shall specify items and quantities to be delivered as well as days to complete Work Order.

**Item 4 – Scope of Work**

This contract may be extended per Special Provision 004-004.

**Item 6 – Control of Materials**

**Item 8 - Prosecution and Progress**

Contract time charges shall begin upon issuance of first material work order placed. One hundred and twenty (120) Working Days have been designated for this contract. Working Days shall be computed and charged in accordance with Article 8.3.1.5 “Calendar Day.”

Individual Work Order charge days shall run concurrently with Contract time charges.

**Item 9 – Measurement and Payment**

In accordance with Article 9.2 “Plans Quantity Measurement,” plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery.

Force account work is being added by lump sum to cover contractor’s miscellaneous costs such as demurrage, diversion fees, additional mileage, and overnight fees. These costs will be paid upon receipt of a written invoice provided by the contractor.

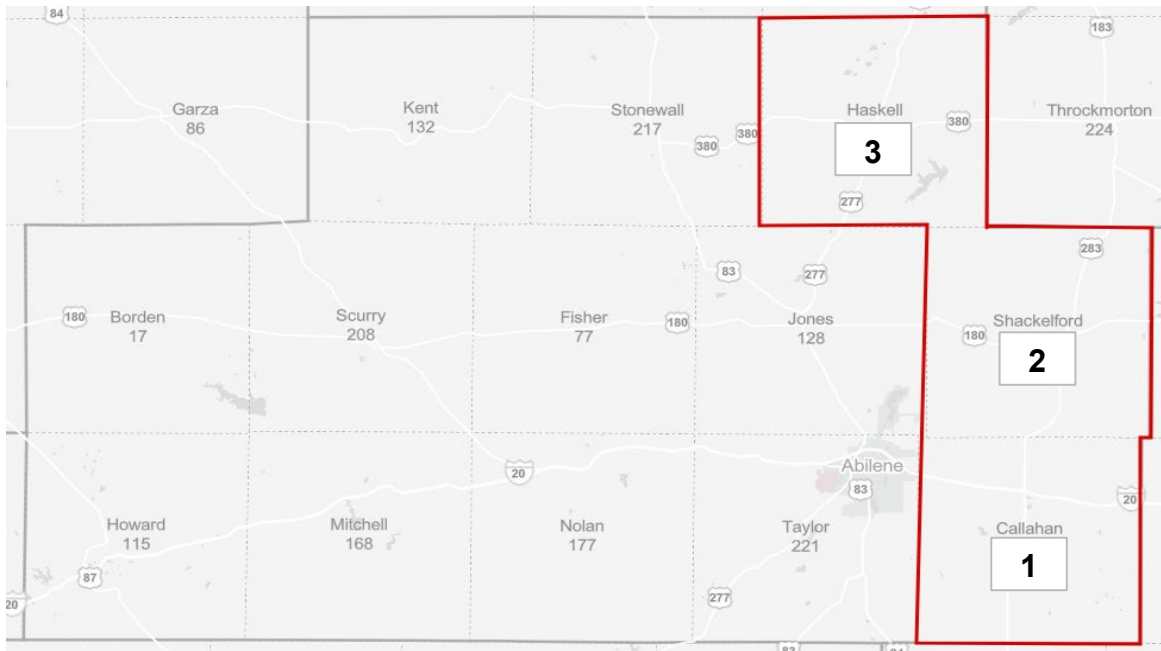
