ITEM 5 – CONTROL OF THE WORK:

Upon completion of the work and before final acceptance and final payment is made, clear and remove from the site all surplus and discarded material and will leave the entire project in a neat and slightly condition.

- Make all deliveries between the hours of 8 A.M. and 4 P.M. CST unless prior arrangements have been made with the Maintenance Supervisor.
- TxDOT will not place orders for less than 24 TONS.
- Material shall be delivered a method capable of placing material in the opening of the salt storage building, i.e. End Dump or Live Bottom trailers.

ITEM 6 – CONTROL OF MATERIALS:

Furnish all material for this project in accordance with applicable specifications.

ITEM 8 – PROSECUTION AND PROGRESS:

Time will be computed according to Item 8.3.1.5 "Calendar Day".

In accordance with Article 8.6 "Failure to Complete Work on Time," liquidated damages will be charged for failure to complete each Work Order within 7 days from the issue date of the work order. All work orders stand on their own.

The amount assessed per day for liquidated damages will be 5% of the estimated cost of the Work Order, not to be less than \$250 per day and not to exceed \$1,000 per day.

ITEM 9 – MEASUREMENT & PAYMENT:

In accordance with Article 9.1," Measurement of Quantities," furnish the tare and maximum gross weights as well as the volume capacity of all vehicles, trucks, truck-tractors, trailers, semitrailers, or combination of such vehicles used to deliver materials for the contract. Also furnish calculations supporting these weights and capacities. Provide all measurements required for pay a minimum of 2 days before the equipment is used.

TY-I

Supply Sodium Chloride (De-Icing Salt) Type I salt for broadcasting on roadway.

Material will be roadway grade salt (Sodium Chloride), in bulk salt form, for the quantity identified on the call-out work order. Bulk salt will be clean and free of debris.

TY-II

Supply Sodium Chloride (De-Icing Salt) Type II salt for making brine.

Material will be brine quality salt (Sodium Chloride), in bulk salt form, for the quantity identified on the call-out work order. Bulk salt will be clean and free of debris.
