ITEM 10.5: CONTROL OF THE WORK

In Accordance with Article 10.8.7 "Default of Contract," liquidated damages will be charged for failure to complete each Work Order in the specified number of days. The amount assessed per day for liquidated damages will be 5% of the estimated cost of the Work Order, but not to be less than \$250 per day and not to exceed \$1,000 per day.

ITEM 500: MOBILIZATION

Mobilization does not apply to this materials contract.

ITEM 502: BARRICADES, SIGNS, AND TRAFFIC HANDLING

In accordance with Article 502.4.1.6 "Contracts with Callout Work and Work Orders," this item will not be paid for separately but will be subsidiary to the contract bid items.

Place barricades and signs in locations that do not obstruct the sight distance of drivers entering the highway from driveways or side streets.


ITEM 8013: HOT MIX COLD-LAID ASPHALT CONCRETE PAVEMENT

In addition to the complete destination address, each delivery ticket must be clearly marked with the work order number. Each shipment must be accompanied by a packing slip.

Contractor's driver shall report to the State's representative at the time of arrival at the final delivery location and obtain signature documenting the date and time.
