The Maintenance Supervisor will make arrangements with the Contractor to have the material delivered to the maintenance yard or the roadway.

When the hot-mix cold-laid asphalt concrete pavement is not being delivered to the roadway, the contractor is responsible for furnishing and delivering the material to the Colorado County Maintenance Yard. The delivery hours will be Monday through Thursday 7:00 AM to 5:00 PM. The Maintenance Section will stockpile the material.

Furnish a certified copy of the legal gross weight of each vehicle hauling materials by weight and certified measurements for all trucks hauling material by volume.

**ITEM 8013: HOT-MIX COLD-LAID ASPHALT CONCRETE PAVEMENT
(MATERIALS ONLY)**

Deliver Hot Mix Cold Laid to the roadway in belly dumps unless otherwise directed by the Maintenance Supervisor.

There will usually be two rounds of material delivered each day. Schedule the trucking so that all the trucks ordered for each round of trucks arrive at the site around the same time. No truck will be dumped and allowed to leave the construction site until all the trucks ordered for that round have arrived on the site.
