By signing this proposal, a bidder acknowledges that he/she has a copy of the "Standard Specifications for Construction of Highways, Streets and Bridges", adopted by the Texas Department of Transportation, November 1, 2014. This specification book may be purchased from the Department.

ITEM 10.3 Award and Execution of Contract

Material requests shall be issued by work order. Each work order shall specify items and quantities to be delivered as well as days to complete Work Order.

ITEM 10.6 Control of Materials

Use materials from pre-qualified producers. A list of material producers pre-qualified by the Construction Division (CST) of the Texas Department of Transportation (TxDOT) can be found at the following website:

ITEM 10.8 Prosecution and Progress

Contract time charges shall begin upon issuance of "Authorization to Begin Work" letter. One hundred and twenty (120) working days have been designated for this contract. Working days shall be computed and charged in accordance with Article 8.3.1.5 "Calendar Day."

Individual work order charge days shall run concurrently with contract time charges.

In accordance with Article 8.6 "Late Delivery Damages", actual damages shall be charged each day for failure to provide material within the specified timeframe for each work order. This will include:

- 1. Failure to produce at the starting date or continually progress on the work order.
- 2. Failure to produce the required number of tons per day.

For this contract, the vendor will have 24 hours from the issuance of the work order to produce the material. The amount assessed per day for actual damages shall be 5% of the estimated cost of the Work Order, not to be less than \$250 per day and not to exceed \$1000 per day.

ITEM 10.9 Measurement and Progress

In accordance with Article 9.2 "Plans Quantity Measurement," plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery. Maintenance Sections may request quantities varying from those shown in the plans to meet their needs.

ITEM 8011 Dense-Graded Hot-Mix Asphalt (Small Quantity) (Materials Only)

This item is for both pickup and delivery of material from the hot-mix plant. Both end dumps and/or belly dumps will be required for delivery by the vendor. 12 YD end-dump trucks should be available upon request. Trailer type will be coordinated with the vendor prior to issuance of the work order.

The vendor shall be capable of providing a minimum of 100 tons per day.

The vendor shall provide mixture Type C or Type D using PG Binder 64-22. No PG Binder grade dumps will be allowed on this contract. It is at the Engineer's discretion to accept a different material if the vendor is producing a superior product.

The use of Recycled Asphalt Shingles (RAS) will not be permitted on this contract.

The use of Recycled Asphalt Pavement will not be permitted on this contract.

Supply aggregate that meets surface aggregate classification (SAC) A or (SAC) B.

The Hot -Mix Asphalt Concrete plant must be located within 50 miles of Odessa Maintenance Office. Various maintenance sections will have the availability of releasing work orders from this contract.


