Section 10.3 – AWARD AND EXECUTION

Time charges and work will start on the date stated on the Work Authorization letter. The Contract will be in effect until work on the last callout is completed.

Section 10.7 – LEGAL RELATIONS AND RESPONSIBILITIES

No significant traffic generator events identified.

Do not discharge any liquid pollutant from vehicles onto the roadside. Immediately clean spills and dispose in compliance with local, state, and federal regulations to the satisfaction of the Engineer at no additional cost to the Department.

Occupational Safety & Health Administration (OSHA) regulations prohibit operations that bring people or equipment within 10 ft. of an energized electrical line. Where workers and/or equipment may be close to an energized electrical line, notify the electrical power company and make all necessary adjustments to ensure the safety of workers near the energized line.

Section 10.8 – PROSECUTION AND PROGRESS

This project is to be completed in **180** calendar days in accordance with **Section 10.8.2**, "Calendar Day."

ITEM 8011 - Dense-Graded Hot-Mix Asphalt (Small Quantity) (Materials Only)

The pickup only item is for TxDOT picking up the material at the plant. This item will not include any delivery on the contractor's part.

For small quantity needs, a work order will be issued to the contractor a minimum of 72 hours in advance and the contractor shall be able to provide a minimum of 100 tons per day.

For larger quantity needs (over 500 tons), a work order will be issued to the contractor a minimum of 2 weeks (14 calendar days) in advance of the project start date. Contractor shall be able to provide a minimum of 1000 tons per day for larger quantity needs (over 500 tons).

Provide aggregates with a Surface Aggregate Classification (SAC) of "A" for TY-D and TY-C mixes. Provide aggregates with a minimum SAC of "B" for all other mixes unless otherwise shown on the plans.

Hydrated Lime shall be added as an additive as per Item 301 "Asphalt Antistripping Agents" between the rates of 1% minimum and 2.0% maximum by weight. If the Hamburg Wheel Test cannot be met within these limits, Liquid Antistripping agents as approved by the Engineer may be used in conjunction with lime.

Supply Warm-Mix Asphalt (WMA) under this Item.

When Reclaimed Asphalt Pavement (RAP) is used in the production of hot-mix asphaltic concrete, use fractionated RAP. Do not exceed 10.0% of Fractionated RAP on TY-D and TY-C mixtures.

Use of RAS (Recycled Asphalt Shingles) is not allowed for any mixtures.

Substitute PG Binders (grade dumping) will not be allowed for any mixtures.

Design the mixture at 50 gyrations (Ndesign).

The delivery bid items are for the Contractor to furnish and deliver the specified material to any location within the limits of El Paso County as directed by the Engineer.
