

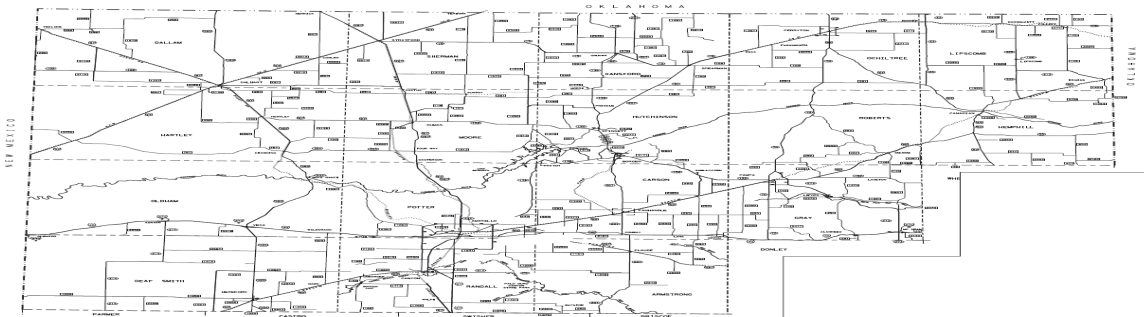



Section 10.2 – Instructions to Bidders

By signing this proposal, a bidder acknowledges that he/she has a copy of the “Standard Specifications for Construction of Highways, Streets and Bridges”, adopted by the Texas Department of Transportation, November 1, 2014. This specification book may be purchased from the Department.

Section 10.3 – Award and Execution of Contract

Material requests shall be issued by Work Order. Each Work Order shall specify items and quantities to be delivered as well as days to complete Work Order.

Section 10.4 – Scope of Work

In accordance with Article 10.4.3.1 when mutually agreed upon in writing by both parties to the contract, the Engineer may extend the contract by change order, up to two times, for an additional period not to exceed the original contract time period.

The extended contract may be for additional quantities up to the original bid quantities, plus any quantities added by previously approved change orders.

The extension will meet the terms and conditions of the original contract, plus any approved terms and conditions made by previously approved change orders.

Section 10.6 – Control of Materials

Contract time charges shall begin upon issuance of "Authorization to Begin Work" letter. One hundred twenty (120) Calendar days have been designated for this contract. Calendar Days shall be computed and charged in accordance with Article 10.8.2, "Contract Term".

Individual Work Order charge days shall run concurrently with Contract time charges.

Notify the Maintenance Section Supervisor when encountering any unforeseen delays.

Section 10.9 – Measurement and Payment

In accordance with Article 9.2 "Scope of Payment," plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery. Maintenance Sections may request quantities varying from those shown in the plans to meet their needs.

Contractor is responsible for obtaining annual overweight tolerance permit if hauling materials that exceed the legal road weight.

Item 8042-Winter Weather Materials (Materials Only)

This contract is for Granular magnesium chloride that meets the specification of TxDOT SS 8042 to be used as a winter weather material product and shall conform to DMS-6400.

Deliver Monday through Thursday during business hours only. Deliveries outside of these times may be allowed at the sole discretion of the Maintenance Section Supervisor.

Material will be delivered by truck load; super sacks will not be accepted.

This contract is for small quantities only, a work order will be issued to the contractor a minimum of 24 hours in advance.

Bid items on this contract are listed to establish a unit price for each item. Certain items listed in the proposal may not be used if it is determined by the Engineer that the work will not be required.
