

Prior to beginning operations, a meeting will be held at the contract administration building to include material supplier and maintenance section supervisors listed in this contract.

Each contract awarded by the Department stands on its own and as such, is separate from other contracts.

All work on this contract will be issued by work order via email. A work order will include the location, the bid item, and the quantity of material to deliver. Callout work orders will be issued based on priorities.

Provide and maintain a dedicated email address for receipt of work orders and correspondence throughout the term of this contract. Respond to all correspondence within 1 business day.

General Requirements and Covenants – Item 10

Project Description – This project shall consist of the purchase and delivery of materials only, Ty E Gr 4 & Ty E Gr 5 Aggregate for the Pampa Area Maintenance Sections consisting of: Groom, Panhandle, Pampa, Canadian, and Perryton maintenance sections. Materials shall be delivered to TxDOT maintenance within the counties listed below.

Each contract awarded by the Department stands on its own and as such, is separate from other contracts. A contractor awarded multiple contracts, must be capable and sufficiently staffed to concurrently process any or all contracts at the same time.

Section 10.2 – Instructions to Bidders

By signing this proposal, a bidder acknowledges that he/she has a copy of the "Standard Specifications for Construction of Highways, Streets and Bridges", adopted by the Texas Department of Transportation, September 1, 2024. This specification book may be purchased from the Department.

<u>Section 10.3 – Award and Execution of Contract</u>

Material requests shall be issued by Work Order. Each Work Order shall specify items and quantities to be delivered as well as days to complete Work Order.

Section 10.4 – Scope of Work

In accordance with Article 10.4.3.1 when mutually agreed upon in writing by both parties to the contract, the Engineer may extend the contract by change order, up to two times, for an additional period not to exceed the original contract time period.

The extended contract may be for additional quantities up to the original bid quantities, plus any quantities added by previously approved change orders.

The extension will meet the terms and conditions of the original contract, plus any approved terms and conditions made by previously approved change orders.

Section 10.6 – Control of Materials

Use materials from pre-qualified producers. A list of material producers pre-qualified by the Construction Division (CST) of the Texas Department of Transportation (TxDOT) can be found at the following website:

Section 10.8 - Prosecution and Progress

Contract time charges shall begin upon issuance of "Authorization to Begin Work" letter. One hundred twenty (120) Calendar days have been designated for this contract. Calendar Days shall be computed and charged in accordance with Article 10.8.2, "Contract Term".

Individual Work Order charge days shall run concurrently with Contract time charges.

Notify the Maintenance Section Supervisor when encountering any unforeseen delays.

Section 10.9 – Measurement and Payment

In accordance with Article 9.2 "Scope of Payment," plans quantity measurement requirements are not applicable for this contract. Quantities shown in the plans are for bidding purposes only. TxDOT does not guarantee that all quantities shown in plans will be requested for delivery. Maintenance Sections may request quantities varying from those shown in the plans to meet their needs.

Contractor is responsible for obtaining annual overweight tolerance permit if hauling materials that exceed the legal road weight.

<u>Item 8000 – Ty E Gr 4 & Ty E Gr 5 Aggregate (Materials Only)</u>

There are 6 delivery site locations shown on the plans. Each location will represent a maintenance section in the Amarillo Area. Specific locations within the county will be designated in the work orders. Each maintenance section will have a separate bid item.

Minimum delivery quantity shall be 25 tons.

Deliver Monday through Thursday during business hours only. Deliveries outside of these times may be allowed at the sole discretion of the Maintenance Section Supervisor.

Notify the Maintenance Section Supervisor at least 24 hours prior to delivery of material.

The Contractors driver shall report to the Maintenance Section Supervisor, or his representative, at the time of arrival at the final delivery location and obtain a signature documenting the date and time of delivery and departure.

A 2-hour unload time per truck will be included in the bid price. If a truck has to stay on site longer than 2 hours, due to no fault of the contractor, each additional 15 minutes will be paid at \$20 per 15-minute increment per truck.
