Section 10.4 – Scope of Work:

In accordance with Article 10.4.3.1, this contract may be extended once not to exceed 360 calendar days for the entire contract term if mutually agreed.

Section 10.8 - Prosecution and Progress:

There are 180 calendar days on this contract. Calendar days will be charged in accordance with Article 10.8.2., "Contract Term".

Each work order will specify a delivery site by the bid item in the contract and quantity to be supplied. The minimum amount of material to be ordered on an individual work order is 25 Tons. There are 7 working days allowed to complete each work order.

Item 500 – Mobilization:

Mobilization does not apply to this Maintenance Materials Contract.
