"Discriminate against a firearm entity or firearm trade association" does not include: (1) the established policies of a merchant, retail seller, or platform that restrict or prohibit the listing or selling of ammunition, firearms, or firearm accessories; (2) a company's refusal to engage in the trade of any goods or services, decision to refrain from continuing an existing business relationship, or decision to terminate an existing business relationship to comply with federal, state, or local law, policy, or regulations or a directive by a regulatory agency, or for any traditional business reason that is specific to the customer or potential customer and not based solely on an entity's or association's status as a firearm entity or firearm trade association.

Violation of this certification may result in action by the Department.

Special Provision to Item 000

Nondiscrimination



1. DESCRIPTION

All recipients of federal financial assistance are required to comply with various nondiscrimination laws, including Title VI of the Civil Rights Act of 1964, as amended (Title VI). Title VI forbids discrimination against anyone in the United States on the grounds of race, color, or national origin by any agency receiving federal funds.

The Texas Department of Transportation, as a recipient of federal financial assistance, and under Title VI and related statutes, ensures that no person will on the grounds of race, religion (where the primary objective of the financial assistance is to provide employment in accordance with 42 USC 2000d-3), color, national origin, sex, age, or disability be excluded from participation in, be denied the benefits of, or otherwise be subjected to discrimination under any Department programs or activities.

2. DEFINITION OF TERMS

Where the term "Contractor" appears in the following six nondiscrimination clauses, the term "Contractor" is understood to include all parties to Contracts or agreements with the Department.

3. NONDISCRIMINATION PROVISIONS

During the performance of this Contract, the Contractor agrees as follows.

- 3.1. **Compliance with Regulations.** The Contractor must comply with the Regulations pertinent to nondiscrimination in federally assisted programs of the United States Department of Transportation 49 CFR 21, as they may be amended from time to time, (hereinafter referred to as the Regulations), which are herein incorporated by reference and made a part of this Contract.
- 3.2. **Nondiscrimination.** The Contractor, regarding the work performed during the Contract, must not discriminate on the grounds of race, color, or national origin in the selection and retention of subcontractors, including procurements of materials and leases of equipment. The Contractor must not participate either directly or indirectly in the discrimination prohibited by Section 21.5 of the Regulations, including employment practices when the Contract covers a program set forth in Appendix B of the Regulations.
- 3.3. **Solicitations for Subcontracts, Including Procurements of Materials and Equipment.** In all solicitations either by competitive bidding or negotiation made by the Contractor for work to be performed under a subcontract, including procurements of materials or leases of equipment, the Contractor must notify each potential subcontractor or supplier of the Contractor's obligations under this Contract and the Regulations relative to nondiscrimination on the grounds of race, color, or national origin.
- 3.4. **Information and Reports.** The Contractor must provide all information and reports required by the Regulations or directives issued pursuant thereto, and must permit access to its books, records, accounts, other sources of information, and facilities as may be determined by the Recipient or the Department to be pertinent to ascertain compliance with such Regulations, orders, and instructions. Where any information required of a Contractor is in the exclusive possession of another who fails or refuses to furnish this information, the Contractor must so certify to the Recipient, or the Department as appropriate, and must set forth what efforts it has made to obtain the information.
- 3.5. **Sanctions for Noncompliance.** In the event of the Contractor's noncompliance with the nondiscrimination provisions of this Contract, the Recipient must impose such Contract sanctions as it or the Department may

determine to be appropriate, including, but not limited to actions defined in Article 7.1., "Ethics," or Article 5.1., "Authority of Engineer."

- 3.6. **Incorporation of Provisions.** The Contractor must include the provisions of Sections 3.1–3.6 in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Regulations or directives issued pursuant thereto. The Contractor must take such action with respect to any subcontract or procurement as the Recipient or the Department may direct as a means of enforcing such provisions, including sanctions for noncompliance: Provided, however, that, in the event a Contractor becomes involved in, or is threatened with, litigation with a subcontractor or supplier as a result of such direction, the Contractor may request the Recipient to enter into such litigation to protect the interests of the Recipient, and, in addition, the Contractor may request the United States to enter into such litigation to protect the interests of the United States.

Certificate of Interested Parties (Form 1295)



Submit Form 1295, "Certificate of Interested Parties," in the following instances:

- at Contract execution for Contracts awarded by the Commission,
- at Contract execution for Contracts awarded by the District Engineer or Chief Engineer with an award amount of \$1 million or more,
- at any time an existing Contract awarded by the District Engineer or Chief Engineer increases in value to \$1 million or more because of changes in the Contract,
- at any time there is an increase of \$1 million or more to an existing Contract (e.g., change orders, extensions, and renewals), and
- at any time there is a change to the information in Form 1295, when the form was filed for an existing Contract.

Special Specification 8002

Winter Weather Materials (Materials Only)



1. DESCRIPTION

Furnish materials commonly used for pre-treating (anti-icing) and treating (de-icing) highways during winter weather events.

2. MATERIALS

2.1. **MPL.** The Materials and Tests Division maintains an MPL for some of the materials in accordance with this Specification. Materials appearing on the MPL titled “De-Icer/Anti-Icer” require no further testing unless deemed necessary by the Engineer. Use of prequalified product does not relieve the Contractor of the responsibility to provide product in accordance with this Specification.

2.2. **Type I Road Salt.** Provide sodium chloride materials in accordance with [DMS-6400](#), “De-Icer/Anti-Icer.”

2.3. **Type II Brine Salt.** Provide sodium chloride materials in accordance with [DMS-6400](#).

2.4. **Complex Chloride (Type III and Liquid).** Provide complex chloride materials in accordance with [DMS-6400](#).

2.5. **Premade Brine Solution.** Provide a premade brine solution in accordance with [DMS-6400](#).

2.6. **Fracking Brine Solution.** Provide a fracking brine solution in accordance with [DMS-6400](#).

2.7. **Type 5 Modified Aggregate.** Provide aggregate conforming to the gradation requirements shown in Table 1 when tested in accordance with [Tex-401-A](#) unless otherwise specified.

2.8. **Type L Aggregate.** Provide lightweight aggregate consisting of expanded shale, clay, or slate, and produced by the rotary kiln method.

- 2.9. **Sand.** Provide fine aggregate consisting of clean, hard, durable particles of natural, manufactured sand; recycled crushed hydraulic cement concrete, slag, lightweight aggregate, or a combination thereof.

Provide fine aggregate or combinations of aggregates conforming to the gradation requirements shown in Table 3 when tested in accordance with [Tex-401-A](#) unless otherwise specified.

3. MEASUREMENT

- 3.1. **Type I Road Salt.** This item will be measured by the ton, cubic yard, or bag size of dry material as shown on the plans and in conformance with Specifications.
- 3.2. **Type II Brine Salt.** This item will be measured by the ton, cubic yard, or bag size of dry material as shown on the plans and in conformance with Specifications.
- 3.3. **Complex Chloride (Solid).** This item will be measured by the ton, cubic yard, or bag size of dry material as shown on the plans and in conformance with Specifications.
- 3.4. **Complex Chloride (Liquid).** This item will be measured by the gallon.
- 3.5. **Premade Brine Solution.** This item will be measured by the gallon.
- 3.6. **Fracking Brine Solution.** This item will be measured by the gallon.
- 3.7. **Type 5 Modified Aggregate.** This item will be measured by the ton or cubic yard of dry material as shown on the plans and in conformance with Specifications.
- 3.8. **Type L Aggregate.** This item will be measured by the ton or cubic yard of dry material as shown on the plans and in conformance with Specifications.
- 3.9. **Sand.** This item will be measured by the ton or cubic yard of dry material as shown on the plans and in conformance with Specifications.

4. PAYMENT

- 4.1. **Material (Pickup).** Payment will be made at the unit price bid for each item. This price is full compensation for furnishing materials, assistance provided in sampling, loading provided vehicles, furnishing scales and labor for weighing and measuring, equipment, labor, tools, and incidentals.
- 4.2. **Material (Delivery).** Payment will be made at the unit price bid for each item. This price is full compensation for furnishing materials, loading, hauling, delivery of materials, furnishing scales and labor for weighing and measuring, providing pumps and hoses for transferring liquid brine solution to a storage tank, equipment, labor, tools, and incidentals. Delivery locations will be as shown on the plans.
