Section 10.4 – Scope of Work:

Prior to beginning operations, the Department will arrange a coordination call between representatives of the Department and the Contractor. In this meeting, the representatives from all parties will discuss the Contract, proposed procedures, and plans for performing the work while providing safe passage for traffic at all times. Specifications, unusual conditions, and other pertinent items regarding the work will also be discussed. Limit the use of the roadway for the hauling of material to legal loads. Keep the traveled surfaces used in hauling operations free of dirt or other materials.

In accordance with Article 10.4.3.1, this contract may be extended twice, not to exceed 540 calendar days for the entire contract term if mutually agreed.

Section 10.8 - Prosecution and Progress:

There are 365 calendar days on this contract. Calendar days will be charged in accordance with Article 10.8.2., "Contract Term".

Types of accepted haul vehicles include End Dumps.

Work Orders. There will be a minimum of seven working days allowed to deliver material as of the date of the work order except for Expedited Work Orders (EWO) as further defined in Article 10.8.5. Issuance of Expedited Work Order. The actual number of days allowed for delivery of materials will be shown in the Contract and work order; however, anything less than seven working days in the Contract or work order (except for an EWO) is not allowed.

Work Order will specify a delivery site by the bid item in the contract and quantity to be supplied.

Unless otherwise directed, prosecute the work continuously to completion of the Work Order.

Item 8014 – Winter Weather Materials (Materials Only):

CAT 8A-R Road Salt- This Item will be delivered in bulk dry material to the locations specified on the Work Order.

Brine Solution- This Item will be delivered at 23.3% salinity and free of foreign debris to the locations specified in the Work Order.

CAT 6, Sodium Chloride - This Item will be delivered in bulk dry material to the locations specified on the Work Order.
